## 2023 VES Campaign

### Objective:

- To continue to provide best-in-class, no-charge, monthly financial education webinars to our full-service plans and participants. The VES (Virtual Education Series) webinars are non-plan specific.

#### Schedule:

- The frequency will continue to be six webinars per month.
- The webinars will continue to be the first Friday and following Monday of each month, with the exception of months that have a holiday falling on those dates.
- Registration links will be updated with the next quarter's webinars the Tuesday after the previous quarter's sessions have concluded.

#### 2023 Enhancements:

- The "On-Demand" feature has been extended from 30 days to 60 days.
- New topic of "Estate Planning (Leaving a legacy)" available for July 2023.

#### VES Spanish sessions (2023):

- Spanish sessions for 2023 will take place on a Quarterly Basis (4x per year) in the second month of each quarter.
